



## Memorandum of Understanding

BETWEEN

**Al Neelain University, Sudan**

AND

**Erzurum Technical University, Türkiye**

### 1. PURPOSE

The purpose of this Memorandum of Understanding is to outline an agreement and working relationship between the **Al Neelain University** (hereinafter referred to as **ANU**) and Erzurum Technical University (hereinafter referred to as **ETU**) beginning with organization of “Turkish Universities Promotion Fair” which is planned to be organized in Khartoum on 5-12 March, 2023.

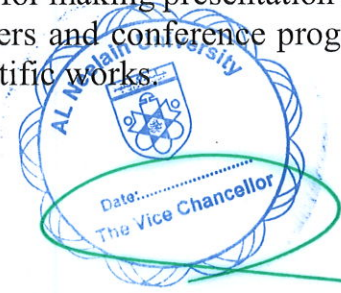
### 2. SCOPE OF COOPERATION

**The scope of this MoU includes, but is not limited to the following:**

- 2.1. The preparation and holding of the “Turkish Universities Promotion Fair”.
- 2.2 The development of collaborative research projects.
- 2.3. The exchange of experiences of good practices in sports, science, and culture (by holding joint academic and scientific activities, such as courses, seminars, training programs, summer schools, conferences, scientific publications etc.).

### 3. IMPLEMENTATION

3.1 In order to organize the Conference, the parties agreed on the following: **ETU** proposes one candidate for the Honorary Organizational Committee, two candidates for the Scientific Committee, as well as one candidate for making presentation at the plenary session; **ANU** places the **ETU** logo on banners and conference programs, participants' certificates, and in the collection of scientific works.

3.2. In order to carry out and fulfill the other aims of this MoU, ANU and ETU, shall each appoint a local coordinator who shall manage the development and conduct of joint activities. The local coordinators shall be responsible for the evaluation of activities under this MoU according to the practices of their respective institutions.

3.3 Specific details of any activity shall be set forth in the form of Cooperation Agreement which, upon signing by the Rector at each institution, shall become an integral part of this general MoU. The specific Cooperation Agreement will be legally binding, including such items as: the responsibilities of each Party for the agreed upon activity, schedules for the specific activity, budgets and sources of financing and any other items necessary for the efficient achievement of the activity.

#### 4.DURATION AND TERMINATION

This MoU shall become effective on the date that it is signed by both Parties and shall be valid for a period of five years, but may be renewed or extended by mutual consent. Any changes to this MoU shall be subject to the written consent of both parties.

This MoU may be terminated by either party at any time provided that the terminating party gives written notice of its intention at least three months prior to termination.
